

National Breed Warden's Message

he start of 2020 has been very interesting and challenging for our clubs and members due to the COVID-19 situation. World, National, and Local events have been cancelled in many countries, some postponed, we have never seen anying like this before.

We are now into summer with USCA events expected to start again after July 15, with several months lost for training for both working trials and shows due to state and local restrictions. Everyone will be happy when life and dog training is back to normal again.

The aftermath of this is that there have been no conformation events for members and breeders to attain their lifetime breed surveys on their dogs that are due in 2020. On my behalf, Vadim has been working with the SV to allow all dogs due for lifetime breed survey in 2020 to obtain a one year breed survey extension. USCA will also allow our USCA only breed surveys to have a one year extension since there have been no events for anyone to make any lifetime breed surveys.

Even when events do start up again, the reality is, SV Judges are not permitted to travel here by our government or theirs yet and we do not know when that will be allowed again. So please rest assured you will be granted an extension so you will not have to deal with a lapsed breed survey. As soon as we have full details from the SV, I will make a breed survey addendum for 2020 lifetimes for BAC approval and we will make an announcement of the details.

Best wishes to everyone for a healthy remainder of 2020 and hopefully events and training gets back to normal soon!

Ladies and Gentlemen:

On the occasion of last year's WUSV General Annual Assembly in Septeber 2019 in addition to the WUSV Breeding Program a uniform procedure for the ranking EXCELLENT SELECTION V-A for the national winner shows of the WUSV memberclubs was approved of as follows:

From January 01, 2020 on, the following minimum requirements need to be met to obtain the ranking of EXCELLENT SELECTION V-A

- DNA* (registered or verified)
- HD and ED: normal, almost normal or still admitted = fit for breeding
- IPO 1 or IGP 1 or Sch H 1 or SV recognized examinations for existing VA a transitional period until 2020 applies*
- First Breed Survey examination with TSB pronounced
- TSB pronounced, drops and releases on the occasion on the qualification trial
- parents with breed survey and examination verified (also for the grandparent-generation)
 *according to its own country regulations

In case that the minimum requirements as listed above are not met the officiating judge cannot grant the title V-A.

Corona Pandemic & Event Scheduling

Ladies and Gentlemen:

The situation in terms of the Corona pandemic is still very tense, and for all we know at this point we will be facing the necessity for prolonged measures that aim at the slow-down and containment of the Corona virus at a nationwide level.

And even though the events and competitions as scheduled by the SV as the main club seem to be rather far away on our current time-frame we cannot deny the fact that all preparations for the participation in these main events are currently already in full swing.

During the past couple of weeks many of our members enquired about the main events and competitions. Many people have become insecure and worry that short-term cancellations might affect them economically. This applies first and foremost for the competitors who are in charge of the planning and organization of the participation at the respective events.

Therefore, the SV Board of Directors is currently experiencing a situation that requires the hardest decision-making process they have ever seen in their career at the SV – in particular since the decisions they now have to work on are not only and exclusively based on reliable facts and findings.

But on the other hand, it is the responsibility of the SV Board of Directors to avoid and ward off any possible damages – either health-related or of economic nature – from the organizers of events, the participants and club members. This is of crucial importance against the background that many people are now facing an insecure future after the crisis coupled with worries about their personal health, their work places and financial situation, and thus it is even more important to provide the people with a clear perspective in terms of the short-term future planning.

For the reasons as outlined above, the Board of Directors discussed the issues pending with the respective expert committees which resulted in the following decisions we wish to inform you about.

- SV National Winner Show & International Championship for Rescue Dogs SV-Bundessiegerprüfung für Rettungshunde & Internationales Championat – with venue in in Bamenohl (National Group of Westphalia) – scheduled for August 06th to August 09th, 2020
 Cancellation of the event and postponement from November 05th to November 08th, 2020 – the venue remains the same.
- SV National Winner Show for Shepherding SV-Bundesleistungshüten with venue in Eimke (National Group of Lower Saxony) scheduled from August 28 th to August 30th, 2020 Cancellation of the event and postponement to 2021 the venue remains the same and the date subject to confirmation.
- SV Championship Rally Obedience with venue in Merseburg (National Group of Saxony-Anhalt) scheduled from August 29th, to August 30th, 2020
 Cancellation of the event and postponement to 2021 the venue remains the same and the date subject to confirmation.

- SV Conformation Show BSZ SV-Bundessiegerzuchtschau with venue in Nürnberg (National Group of Bavaria North) scheduled from September 03rd, to September 06th, 2020
 Cancellation of the event and the WUSV Annual General Meeting for the year 2020.

Reading Your Canine Partner

By John Howard, Co-Owner, Kinetic* Performance Dog Food

While our dogs cannot speak to us, they tell us a lot through visual cues on energy levels, drive, body condition, stool quality and other behavioral indicators. Much of what we do in evaluating a nutrition program and how well it fits certain dogs is looking at these signs. When we cannot do it in person, we draw on handler interviews and photos they provide to assist us in the process.

As a bit of change to our normal articles, we thought it might be helpful to cover some of the visual cues we evaluate with handlers across the country. As part of our process, we request a lot of before and after pictures to illustrate the changes. They are not always the best quality photos, as you are about to see, but they are good enough to tell a story. All the photos shown are active, working K9s that have transitioned to our feeding program due to significant feeding challenges.

Skin Condition

You can see in the "Before" photo that there is somewhat of a dry look to the coat and there is significant flaking taking place. Healthy skin should be supple and slightly oily with only minimal, if any, dander present on the coat.





In the "After" photo, the coat color is now more of a rich, glossy liver color and no flaking is visible. The time between these photos was about 45 days, or roughly one bag of dog food, later.

Coat Quality

The condition of the hair coat is another obvious sign of health in a dog. Dry or brittle hair, excessive shedding and uneven hair length are warning signs to watch. In the "Before" photo, this dog appears to have a shaggy look and tufts of hair near the haunches that look ready to come off in clumps.





In the "After" photo, the dog has a smooth, glossy and uniform coat. The color has even transformed to the point where you wonder if it might be a trick of lighting or a different dog. We see this quite often, particularly in German Shepherd [Dogs], and have more detail in our next example.

Coat Color

This dog is another great illustration of the significant impact of diet on coat health. In the "Before" photo the dog looks somewhat washed out. The coat was very dry and there was significant variation in color throughout the coat. The dog was also having great difficulty maintaining weight and stamina.





As with most of these examples, the lag between these photos is approximately after feeding one bag of food. Again, you can see significant color changes in the coat of the dog. The coat has become darker and more uniform and has taken on a glossy sheen. They were also able to reduce feeding volume by roughly 40% with improved weight maintenance and stamina.

Weight Maintenance

This Border Patrol dog has been a poster child for us for a couple years on the benefits of a bio-available diet. The "Before" photo has the dog showing more rib than the handler wanted, and he was feeding 8 cups of food per day to reach that level. The dog remained lean and with insufficient muscle development.





The "After" photo was taken exactly one month after switching to Kinetic and with the feeding amount reduced to 4 ½ cups per day. The ribs are no longer prominent, but the rippling muscles are now readily visible.

Eyes and Ears



With this Dutch Shepherd, you can see discharge below the eyes and washed out coloration on the face and ears. The coat wash was visible all over the dog and significant itching issues were also present.


The "After" photo shows brighter, clearer eyes and darker, more vivid color on the face and ears. The handler also reported significantly reduced scratching and greatly improved stamina for this beautiful dog.



Posture & Attitude

This is the same dog we used in the skin example earlier and one of the most dramatic transformations we have ever seen after a short time on our food. The "Before" photo shows a dog in distress that is neither comfortable nor confident in his bearing. The body is hunched and the tail is tucked.





In the "After" photo you see a dog that no longer appears distressed. He is leaning forward with good posture and the tail is straight and relaxed. As in the earlier photo, you can also see hair that has transformed in color and no longer has flaking skin throughout the coat.

Bringing It All Together

One thing we did not cover here is stool quality. While we have a bunch of photos of dog stools, we do not want to publish them for dog people who know a good stool from a poor one. Beyond that, these visual signs paint a fairly comprehensive picture of what a healthy canine should look like. If your dogs look good across these areas, you probably have a pretty solid nutrition, feeding and management program. If not, feel free to reach out to us and we will be happy to consult with you on potential improvements.



Is Cookout Food Hazardous to Dogs?

Key Points

- Grilled steak bones, ribs, and chicken bones cause choking and throat damage to dogs.
- Garlic and onions in any form are toxic for canine consumption.
- Licking the fatty leftovers around the grill can result in pancreatitis.



With warmer weather comes the chance to fire up the grill and enjoy a cookout. Dog owners may be tempted to let their dog have a taste of the delicious grilled foods. However, many cookout foods are not safe for dogs to eat. Here are a few tips on foods to watch out for:

Bones

What's better than a nice juicy grilled steak or barbecued ribs or chicken wings? But sharing these with your dog is a dangerous idea. Dr. Jerry Klein, AKC chief veterinary officer, warns that you should never give your dog cooked bones of any kind. They splinter into shards that can cause choking and serious damage to the dog's mouth, throat, or intestines.

Raw Meat

Raw steak or hamburger patties can contain bacteria, such as salmonella and E. coli that can be harmful to dogs, as well as people. Keep a careful eye on the meat as you prepare the grill because the aroma will definitely get your dog's attention, and he may try to sneak a tasty morsel.

Hot Dogs

Hot dogs often contain ingredients that are not good

for dogs, such as sodium nitrate, which has been linked to cancer; monosodium glutamate (MSG); and sugars or artificial sweeteners. Hot dogs also contain seasonings, such as garlic and onion powder, that are toxic to dogs. The biggest problem with hot dogs is salt. Feeding your dog even one-half of a hot dog would probably put him way over his daily sodium limit, and too much sodium can lead to dehydration and high blood pressure. Another issue with hot dogs is that they are a choking hazard.

Toppings

Garlic and onions can cause stomach upset in dogs, and sometimes have even more serious side effects. Raw or cooked, fried or powdered, onions, and the rest of the allium family (garlic, shallots, leeks, and chives) are all harmful to dogs. Onions contain a toxic compound that causes a breakdown of red blood cells, leading to anemia in dogs.

Ketchup, while not toxic for dogs, is best left off of the foods you share with your canine pal. In addition to tomatoes, commercial ketchup typically contains garlic and onions, cinnamon, sugar and salt, preservatives and chemicals – and many of these ingredients can have detrimental effects on dogs. Mustard can upset a dog's stomach and cause vomiting.

Corn on the Cob

Corn on the cob is a summertime staple, and although a small amount of corn won't hurt, you should not share your corn on the cob with your dog. There is a risk that he will choke on it, and if he ingests the cob, it can cause a serious intestinal blockage. So, unfortunately, it's not a food you should allow your dog to gnaw on.



Salty Snacks

Potato chips, pretzels, peanuts, and popcorn – all make nice portable snacks when you eat outside. But too much salt can lead to sodium ion poisoning in dogs, causing vomiting, diarrhea, tremors, fever, and seizures – and can even be fatal.

Watermelon

Watermelon is safe for dogs in moderation with these precautions: Seeds could cause an intestinal blockage, so make sure you remove them. It's also not a good idea to allow a dog to chew on the rind, because it can cause gastrointestinal upset.

Chocolate

Whether it's eaten in ice cream, cake, or straight on, chocolate is dangerous for dogs, and depending on the type and amount of chocolate consumed and the weight of your dog, it could cause a serious medical emergency. So the safest path is to avoid giving your dog chocolate at all times in any form.

Ice Cream

Although it's refreshing, ice cream is a milk-based product, and dogs' bodies are not designed to digest milk after they are weaned as puppies. Since ice cream is made with milk, feeding your dog ice cream could lead to gas, bloating, constipation, diarrhea, or vomiting.

Alcohol

An ice-cold beer, a mojito, or margarita may sound refreshing, but don't let your pup dip into any alcoholic beverages. Alcohol toxicity is not very common, because dogs are not innately drawn to alcoholic beverages. However, they may be attracted to fruit-based drinks, cocktails, punches, ciders, seltzers, and foods with alcohol as a key ingredient. Another serious consideration is diet alcoholic beverages or other mixers that may contain Xylitol, an artificial sweetener, which is highly dangerous, and even fatal, if consumed by a dog.

Caffeine

Caffeine can be fatal for dogs. This includes the beans and grounds for coffee, hot tea and iced tea, sodas with cola, energy drinks, and chocolate drinks. Their high sensitivity to caffeine can cause dogs to experience hyperactivity, increased heart rate, and cardiac arrhythmias, high blood pressure, tremors, seizures, vomiting and diarrhea, a high fever, and coma.

Leftovers

Most dogs will be attracted to the grill, especially when you cook meat. Don't let them lick up the fat that drips from the meat because it is rich in oils that can cause pancreatitis. Symptoms include: vomiting, diarrhea, intense abdominal pain, hunched back, weakness, and fever, and pancreatitis is life-threatening if untreated.

If you have a charcoal grill, be aware that although charcoal isn't poisonous, it may upset your dog's stomach if he eats it. It commonly causes vomiting, diarrhea, and loss of appetite. Large pieces could also lead to obstruction and choking.

What Should I Do If My Dog Eats Something Toxic? If you think your pet has gotten into something potentially toxic, call your veterinarian right away. When it happens outside of office hours or any time, day or night, weekends, and holidays, you can call AKC Reunite's Pet Poison Helpline at 800-252-7894 for help.

As experts on the potential danger of the substances dogs eat, the Pet Poison Helpline is the go-to resource to assist if your pet accidentally gets into something. They will recommend the necessary steps to help treat your pet. This may sometimes include getting the dog to an emergency vet as soon as possible. (AKC Reunite subscribers have lifetime access to the poison helpline for a single additional \$15 fee.)

What Human Foods Can My Dog Safely Eat? Although dog foods might not be appealing to us, most contain all of the nutrients dogs need to stay healthy. However, there are many fresh summer fruits and vegetables that are safe for you to share with your dog, such as blueberries, cantaloupe, cucumbers, and peas. Meet Your Judges

Background Information on some of our Judges & Frequently Asked Questions or Mistakes made by Competitors

Our USCA Judges Program (Judges College) is fortunate to have a very dedicated group of judges that have and are all in one way or another active in dog sport. Our USCA Judges are actively participating in dog sport by currently training, competing with their dogs, teaching at handler or helper seminars associated with our USCA events or in many other ways contributing to the GSD and working dog sport (IGP/RH/Shows). All of our judges have trained and titled a minimum of two dogs as Handler Owner Trained (HOT) BH-SchH / IGP3 and FH, and competed at club, regional and national events just to meet the entry requirements for the USCA Judges Program. Most of our judges have far exceeded those minimum requirements having titled and competed with six to as many as 10 or more dogs during their involvement in dog sport.

The USCA Judges Program requires a minimum of two walk along trials to get a feel for what will be expected of them as apprentices and to gauge their entry level of knowledge. This is followed by a minimum of six apprenticed trials evaluating a minimum of 65 dogs at different levels from the AD to BH through IGP1-2-3 and FH. Each trial and dog evaluated must have a written report summarizing the overall trial as well as a summary on every exercise for each dog evaluated. This report must then be submitted to the teaching judge for the event and all evaluations must be in the same category (generally within five points of the teaching judge). The teaching judge will review the apprentice report to determine that the apprentice reached his/her evaluation (rating and points) for each exercise by correctly using the guidelines of the current rules as well as correctly evaluating the overall working temperament of the dog. If the apprentice is passed by the presiding teaching judge they then proceed to the next assignment. Failure of one apprenticeship may require a restart of the program and failure of two apprenticeships is expulsion from the program, allowing for readmission at a later date as determined by the Judges Committee. On completion of the apprentice program they are issued a "Probationary

License" for a period of three-years during which time their work as a judge is reviewed by the Director of Judges, Assistant Director of Judges and the Judges Committee.

Our USCA Judges are continually updated with changes and clarifications to the rules through continuing education as well as a yearly Judges' Meeting and mandatory testing to maintain their license. It is the goal of the USCA Judges College to provide our members, clubs and events with judges that are competent, fair, well-educated and are a resource to our members and clubs to promote the German Shepherd Dog and Working Dog Sport.

Ann Marie Chaffin — USCA Performance Judge, SV Judge, National Level Judge and our Assistant Director of Judges. Ann Marie is and always has been very active in breeding, training and titling/competing with her dogs, having many times titled dogs to SchH/IGP 3 level. She

actively helps many USCA members in her USCA clubs to earn titles and compete at National levels. Ann Marie is involved in all levels of our USCA Trial Administration, reviewing all authorizations, trial paperwork, working on the USCA Rulebook and with our USCA Office Staff taking care of member's questions and helping make our USCA Judges' College education and meeting the success and "gold" standard that it is (USCA is the only working dog organization in America that has, for more than 20-years, held an annual meeting and requires continuing education and a yearly testing of our

judges). Ann Marie was also one of the core members of the USCA team to organize and host the WUSV World Championship for USCA. She was one of the founding members/officers of the AWDF and very actively involved with the AWDF creation and its intentions to unite the different working dog breeds in the United States.



Heidi Theis - USCA
Judge. Heidi is a Trial,
Show, and Breed Survey
Judge for USCA. She also
happens to be our current
USCA National Breed
Warden. She is open and
friendly to all competitors
and treats everyone with
respect. When time
permits, she will happily
help or answer questions

from competitors, trial/show secretaries, club members, or even spectators when she is judging for one of our clubs.

Heidi believes in promoting both working ability and correct conformation in our German Shepherd Dog breed and not the extremes. She is very active in our dog sport as she not only trains her own dogs, she is also the Training Director for her club.

Heidi titles her dogs, which are mostly females, to IPO or IGP 3 level and always breed surveys her dogs. Heidi has a busy year planned ahead when we start having trials again. She plans on FH 1 and a repeat IGP 3 on one of her females, an IGP 3 on her other female this fall, and IGP 1 & 2 and breed survey on her young male.

The most frequently seen mistake she sees is BH handlers on the long down. "They down the dog then take the leash off and put it away, even though I discuss it in the Handler meeting and state in first critiques, people still do it wrong. The correct procedure is to remove the leash with the dog in Basic Position and then down the dog. At pick up, the dog should be in the Sit Basic Position and attach the leash."



Bill Szentmiklosi — USCA Performance Judge, SV Judge. In my lifetime, I have shown over 200 times, titled eight dogs and I am working on my ninth. I have titled six to SCH3 (IPO3) and FH. Two have been my patrol service dogs, which were shown, 3x in the DPO, when combined with the USA Nationals. In

addition, I have competed in four USCA Nationals (SCH/IPO). I was instrumental in revamping and writing the Teaching Judges Program which is currently being used.

I try to limit my judging to four or five trials, two to three private seminars, and one to two helper seminars annually. I am currently active in a club and training another dog. Hopefully this fall and next spring and I can start to show him. This past year has been challenging between caring for older parents that have taken ill and the current pandemic. Even the opportunity of tracking and obedience has been a rarity. The biggest challenge at time is the handlers meeting prior to each phase, with the many nervous competitors. Mistakes seem to still occur. At the local level, mistake(s) may not be pointed, or minimally, if it is nervous handling that does not influence the dog's behavior significantly.

Frequently asked questions or mistakes: During seminars/trials there have been three questions that are often addressed. In tracking: the proper setup and approach to the start with commands. "The answer is clearly defined in the rule book: the dog should be with the Handler not in front, calm with the tracking line attached and trailing behind the dog. At the start the Handler should give a voice command to start when the dog is at the scent pad."

In obedience: how to make the transition from training to trial. They seem to comment that in training they are excellent, yet at the trial they seem to falter. "The answer is that there are many factors. Generally it is due to not enough "proofing" and training in trail like situations."

In protection: how to determine the value of the dog. For example, what do we (Judges) look for in the dogs

activity throughout the performance. The problem they see is, if a dog is barking actively and spellbound why he may not be rated as excellent. "The answer is that the Judge is looking at the dog's complete working temperament, not just training but the physical and mental ability of the dog to perform."



Michael Caputo — USCA Judge. Up through the lockdown, Mike spent most of his non-judging time focusing on his seminar "How to maximize your points", which was recently updated with the new IGP rules package. In addition, he has been at club training sessions with

the Michiana Working Dog Association since taking a hospital consulting opportunity in Northern Indiana. His efforts also continue at preparing education materials for the Judges College continues and he is currently working on a ten-year retrospective look at obedience scores from our major national events.

"The most frequent mistake I encounter seems to come from the tracking field. Handlers still today, do not know the correct way to approach the dog at an article, show the article and provide praise for a job well done. Folks are still placing one hand on the dogs withers/shoulder while simultaneously picking up the article!" Answer: "Do not touch your dog, except to praise, either before or after showing the article."

Perhaps my most frequently asked question, one that has been voiced now for some 33-years is: "Do you judge the SchH3 dogs stricter than the 1's and 2's'?" There is also a variant to that question... "Do you judge harder at a National or Regional event than you do at a local club trial?" The answer is "ALL levels are judged to the rules. The main difference is Handler mistakes that do not influence the dogs performance are often not faulted at club level trials, but will be mentioned in critiques. Also what many newer Handlers do not take into account is the level of distraction at a National event and the intensity of the helper work is not the same as most club trials where the dogs are more comfortable so scores reflect this."



Robin Ayling — USCA Judge. Recently this seems to be a "frequent" asked question: "If the start and end of a exercise is a sit why can't I pet my dog in the group after he sits". The answer is: "The sit in the group is still part of the heeling exercise, the exercise has not been completed."



Andrea Duggan — USCA Judge. Andrea is also the Director of Judges for the German Shepherd Schutzhund Club of Canada. She is actively training and competing. Andrea has judged at the club, Regional Championship and National Championship levels.

Andrea says her most frequently asked question is "How many points do I loose for... "insert phase". The best answer is, "Let's look at the rating first. There are of course mandatory points for certain things but the rating category is very impressive."



Craig Groh — USCA performance Judge, RH2 Judge, SV Judge. Craig is actively training and trialing. He has competed at Regional and National levels. He along with USCA Judges Karen Macintyre and Stefanie

Dunion are the only Judges to earn RH2 titles on their dogs and in turn are licensed to award RH2 titles.

Craig has served on the USCA EB many times, most recently as Vice President. Craig is active with the USA Youth Program having been one of the founders of the program and both he and former USCA Judge and National Breed Warden Johannes Grewe were the leaders behind USCA's greatly successful hosting of the WUSV World Championship.



Don Yelle — USCA Judge.
Don has judged club,
Regional and National
events. He is the Regional
Director for the NE
Region, is Co-Chairman
of the USCA Helper
Committee, a Teaching
Helper and National Level
Helper. Most notably as
a National Level Helper
Don has worked more

than 1,000 dogs officially in his Helper Book, many times at championship level events. Don is very active breeding, training, and competing at all levels of events as well as being the Training Director of his club.



protection. As a national level competitor, Jacob and his dog, Hammer von Heaterproof von Stanford, won the 2013 GSDCA – WDA FH National Championship and were members of 2015 WUSV USA World Team. He and his current dog, Heaven von Tapferen Krieger, won the 2016 South East FH Regional Championship, the 2017 GSDCA National IPO Championship, and placed 5th at the 2019 USCA Championship. Jacob is best known for always having top level FH tracking dogs.

As a judge Jacob stresses the importance of Handlers knowing the difference between losing dog points, Handler points and Team points. Dog points are going to happen because we train animals not machines. Handler points come with a greater point deduction because the dog is not given the opportunity to demonstrate its ability to perform a give exercise. And Team point deductions are usually lost on the training field long before entering a trail. Once a Handler understands where the point deductions are coming from, then it becomes their responsibility to make adjustments before showing again.

Trevor Elcock — Trevor is one of our newest apprentice judges. He is actively working at completing his apprenticeship and is doing a great job! Trevor is active in training and competing with his dogs and is active in his USCA Club.

As judges we are often asked questions by our members and competitors. Judges Committee Member and National Competitor Beth Bradley presented some questions that she has heard at recent events and together with USCA Judge Michael Caputo they put together the following responses:

Tracking

Q: At report in / report out, other than the Handler / Dog team taking the Basic Position and indicating how their dog will indicate the articles, or on report out indicating that the tracking is complete and presenting the article found by the dog, what else would the judge be looking for from the Handler?

A: A sense of self-confidence and professional discourse with the Judge.

Q: During the working of the track, other than what is stated in the rule book, what else would the judge be looking for from the Dog?

A: An overall picture of self-confidence with drive (tracking or hunt) and a clear "work ethic" to solve the puzzle of the track as it has been presented.

Praise

Q: Must the handler maintain a three-second pause after praise at the article before giving the command to track?

A: Yes

Further evaluation criteria / responsibilities of the Judge

Q: What is your definition of desire and confidence?

A: This is very subjective, but generally the Judge wishes to see significant "want to" for the work coupled with a clear picture of nose work to solve the puzzle.

Scent Pad & Working the Track

Q: Must the Handler stand in Basic Position, hand at his side as the leash pulls to the end or do you allow one hand to be behind the handler so he knows the end of the leash?

A: One or two hands on the tracking line is permitted, In most cases two hands are preferable to assure a smooth transition from a stationary position to following the dog. But this is not required, as long as the handler is standing, does not move into the track before the dog reaches the end of the tracking line it is a correct start.

Q: Other than Taking in the Scent Pad in an undetermined amount of time, what else would you like to see from the dog at the Scent Pad?

A: A deep nose, intense working, while maintaining calmness. The time spent on the scent pad is not directly relevant to the overall evaluation of the tracking unless it is evident in the first leg of the track that the dog did not convincingly take up the scent by using the scent pad.

Indicating the Articles: Indicating
Q: Do you want the Handler looking to you before approaching the dog at the article?

A: No, the rules only require the Handler to stop when the dog has indicated the article, place the line on the ground and then approach the dog. A pause of three seconds is always a good habit to clearly show that the dog has indicated the article and clearly allows the Judge to see the dogs behavior indicating the article.

Restart after Article Indication:

Q: Does the Handler restart in the Basic Position and arms stay at their sides until the end of the leash or can the handler have one hand behind so she/he knows the end of the leash?

A: Two hands on the tracking line is permitted and preferable to assure a smooth transition from a stationary position to following the dog.

Q: How would you like the dog to restart from the Article? Should he stand and begin tracking at the down position or one step forward?

A: If the dog's work ethic and drive are strong, he will have his nose in the track and stand simultaneously. Overall the dog must show a balanced, controlled intensity into the track. Leaping

Corners:

Q: May the Handler keep both hands on the leash at the corners?

A: Yes

Q: May the dog back up to the corner if he passes it or is that considering "circling"?

A: Backing up and circling are two distinctly different behaviors. Both could be okay considering the present conditions. Rules require that the dog not "leave the track".

Q: What other behaviors might you point both dog and Handler for at the corner that is not indicated?

A: A corner not indicated is a corner not worked (shown) and points may be lost depending on the value of the corner.

A: Speed changes into or out of the corner may be faulty dependent of the overall terrain or difficulty of the track.

Obedience

Heeling on Leash and Free Heeling:

Q: *Is barking and whining faulty?*

A: Yes, very much so. This behavior will lead to a deduction of a maximum of as much as one category

Recall / Front / Finish:

Q: What are deductions for tone of voice? i.e. commands that are screamed or very harsh are now said to be faulty.

A: This addressed in the rules that commands are given in a "normal voice". This is somewhat subjective; however, most Judges will consider it faulty and there will be a deduction for overtly loud, strong, screaming type commands. This is more strongly enforced at championship events.

Q: Will the dog be pointed for touching the Handler in the Front?

A: Slightly is okay. However, if that touch causes the handler to move, the picture may no longer be excellent.

Q: May the dog touch the Handler in the Finish?

A: Yes, but not enough to cause the Hander to move. Absolute perfect position for the dog / Handler is as close as possible without touching.

Q: May a dog have one foot off the ground?

A: Yes, however this picture may sometimes be considered "submissive" or said another way, lack full self-confidence. This is also based on the dog's overall behavior throughout the performance and is one of many things the Judge is evaluating.

Motion Exercises:

Q: When the Handler returns, what behaviors are you looking for in the dog? Front feet on the ground?

A: A picture of self-confidence and willingness to perform. Looking for the next command from the Handler.

Q: What is your definition of "pressure"?

A: The appearance of the lack of self-confidence, sureness or uncertainty. This is often displayed in submissive behavior, tail down between the legs, head or ears down, hesitant behavior. This applies to all phases and exercises.

Retrieves:

Q: The exercise must begin by looking to the Judge in the Basic position. Is the Handler allowed to move his arm to the outside of the dog's head to throw the dumbbell?

A: Yes, maintaining balance without influence to the dog.

Q: May the Handler step forward to throw the dumbbell?

A: Yes, but only one leg and it will normally be the leg on the same side as the arm that throws the dumbbell.

Q: Must the Handler's arms be at his side when the retrieve command is given?

A: Yes, that describes the Basic Position.

Q: Other than above, what else would you be looking for the dog to do before the throw?

A: A picture of self-confidence, power and willingness to perform. Focused on the exercise and the handler for a command.

Q: Is barking and whining faulty? During the retrieve?

A: Yes

Q: May the dog touch or bump the Handler in Front?

A: As answered in the recall, any contact is faulty but slightly touching is normally okay. However, if it causes the Handler to move, it is then faulty.

Q: How close must the dog be upon presentation?

A: Close enough so that the Handler may take the dumbbell without having to move from the Basic Position. In the case of a very tall Handler, slight bending over may be necessary and not faulty. In general the dog must be close enough to allow the Handler to easily take the dumbbell. Again, absolutely perfect position is as close as possible without touching.

Q: May the Handler praise after the finish of each exercise?

A: Yes, always as described in the rules after a threesecond pause at the end of each exercise. This is a Handler option.

Send out with Down:

Q: May the Handler praise after the sit command upon picking the dog up and before moving to reporting out or down?

A: Yes, provided that a three-second pause is demonstrated after coming to the sit position.

Q: Since the sit is technically part of the send out, when you pick up your dog, must the Handler look to the Judge before sitting his dog?

A: Yes, it is defined in the rules that the Handler look to the Judge and at the instruction of the Judge commands the dog to sit.

Down under Distraction:

Q: May the dog roll from hip to hip during the down?

A: An occasion roll is okay, assuming it is seen. The rules require the dog to remain in place.

Q: Is initial sniffing ok or pointed?

A: The initial "evaluation" of this new environment is okay so long as the dog remains in place.

Q: Is the dog pointed for lying its head down on the ground during any of the down exercise?

A: No, this posture is not addressed in the rules. Unless it is determined to be due to "stress or pressure" exhibited by the dog due to training.

Protection

Search for the Helper:

Q: When the Handler takes the Basic Position at the start, may he step or must he pivot in place?

A: It is most correct to pivot, but a very small movement / step as the Handler turns toward the first blind is allowable.

Q: When the Handler sends the dog to the first blind, may he step toward that blind?

A: No, but the Handler is allowed to use their arm to help direct the dog towards the blind and, although not directly addressed in the rules, a movement of one foot / leg as the arm is extended is allowed.

Q: Should the dog search every blind by looking in? Or is being close enough so the dog can peripherally look in enough?

A: Close enough for peripheral observation is permitted. The dog must give the impression that it is aware of the empty blind.

Hold and Bark:

Q: What distance is 'close' enough to guard? The dog inside the blind? The dog immediately outside of the blind?

A: The dog should be close enough to show clear dominance, but not so close as to touch the Helper.

Q: What is your definition of "dominance"?

A: A clear picture of self-confidence, strong and continuous barking, very controlled aggression, eyes fixed on the Helper.

Q: Is bouncing/jumping without touching the sleeve faulty?

A: This is not specifically addressed in the rules. It could be slightly faulty considering the concept of "controlled aggression" but must be evaluated independently of each dog's behavior.

Grips:

Q: If the Helper does not allow for the dog to get a full grip, does the dog receive full points if he attempts to get the full grip and finally gets a full grip upon lock up?

A: More often than not, fullness of the grip originates in the dog, not the Helper. However, if the grip corrects to full during the pressure phase, it would then not be faulty, or as faulty, given that it is calm and firm.

Q: Is growling on the bite faulty?

A: YES, because our trials are also a breed suitability test and vocal or growling is not a trait that should be promoted in the GSD. Some dogs are vocal during the fight while growling and it can also be a sign of aggression or weakness. The Judge will look at the entire picture to decide between the two and determine how faulty the behavior is and the deduction.

Back Transport:

Q: Does the Helper pause after eight paces or continue to move?

A: At the Handler's instruction the Helper should move back, turn and move out to a distance of eight paces from the Handler / Dog team and stop until instructed by the Handler to move for the back transport.

Q: May the Handler give a command for the dog to attack?

A: No. At no time in the protection may the Handler give an "attack" command. This is cause for DQ. Only in the "escape" the Handler must give a "go or release from the down position command" and in the "Attack on Dog Out of Motion" (courage test / long bite) the Handler may also give a release or send command. But at no time is an "attack or bite command" allowed.

Attack on the dog out of Motion:

Q: Once at the end of the field, may the Handler stop with his back to the Judge and his dog in Basic, then give the command to heel and turn toward the Helper and Judge, show the Basic Position, and then grab the dog's collar if he wishes?

A: Yes

Q: At what distance must the Helper show the sleeve to the dog?

A: The sleeve is usually seen from the start of the exercise when the helper turns. "Presentation" for a safe catch typically occurs just prior to contact. Refer to the USCA helper program for a full explanation.

Side Transport:

Q: What is the correct position of the dog? The dog's head by Helper's leg? Shoulder by Helper's leg?

A: Between the Handler and Helper, shoulders to knees, with focus on the Helper.

Completion of Phase C Protection:

Q: Must the Handler stop after heeling away from the Helper, show the basic position (with a sit) before reaching for the dog's collar?

A: Yes, to be a perfect picture. But stopping with the dog under control when reaching for the collar to leash the dog is allowed.

Q: Is the dog allowed for the dog to get up from a sit once his collar is touched or must he remain in the sit position?

A: Again what is important is that the dog is calm and under control.

Q: Should the Handler show obedience to the critique?

A: Yes, basic control and obedience, the dog must always be in control by the handler.

Weighted Leg Cuffs versus Weighted Vests as Tools of Loaded Resistance Exercise for Canines

AUTHOR BACKGROUND & CONFLICT OF INTEREST DISCLOSURE:

The author is a practicing physician, actively competes in competive IGP dogsport, holds a multiple country patent on a version of canine weighted leg cuffs and also manufactures and sells weighted leg cuffs to competitive dog handlers world-wide.

The goal of creating a simple universal tool to achieve canine physical conditioning and fitness has been pursued for many years. Weighted leg cuffs have been used by veterinary rehab centers in Europe and Sweden for the structured recovery of power and mobility in dogs after TPLO and other orthopedic surgery with great success. In the US both weighted leg cuffs and weighted vests have grown in popularity in recent years.

Weighted leg cuffs have been used in high level competition dogs (the dogs in the US teams competing at the WUSV & FCI have used this; as well as several world class competitive dogs from other countries).

Weighted vests have been used to a larger degree by everyday pet owners and to a large part by noncompetitive dog trainers. Both weighted cuffs and weighted vests have ardent supporters and detractors of their use.

By contrast critics of weighted resistance exercise have held to the position that ALL USE of weighted loads as a form of resistance exercise in canines should be avoided (except by highly trained professionals) and have instead focused on the promotion of gravity & body weight based resistance exercise as methods of canine conditioning. The arguments presented by these critics are based on the need for some degree of training and skill to safely exercise a high drive canine with wearable weights and the very low prevalence of skilled dog handling or training expertise in the general population even after training is given. Other arguments include observations of poor owner compliance with instructions and anthropomorphized notions of animal care and handling that lend to owner behaviors where dogs are treated not as canines but as "fur babies" and mini humans.

Reliable studies on weighted vests as well as weighted leg cuffs have also been lacking so far, therefore the arguments of both camps have not be encoherently examined. This paper is a review of recent literature that brings up new data to clarify ambiguities in this area of public value and importance.

According to the manufacturer of one type of weighted leg cuff (ActoBands, ActivPower Inc.), the use of weighted leg cuffs by non-professionals is reserved for dogs and use scenarios that must meet the following criteria:

- 1) Dog should have no obesity
- 2) Dog should have no injury or joint dysplasia
- Dog should have no Cardio-pulmonary disease
- 4) Exercise should be restricted to leashed walk only
- 5) Exercise should be restricted to duration of 10-15 minutes
- 6) Weights should not exceed 1-3 grams per kilogram body weight per leg
- 7) Veterinary approval of training program is recommended
- 8) Escalation of exercise intensity and loads is distributed in 2-3 week increments over 12-16 weeks

As mentioned earlier, there is a dearth of well-designed studies examining the use of weighted leg cuffs as a resistance training tool in dogs. Weighted leg cuffs however has been used by veterinary rehabilitation professionals in Sweden and Europe for the recovery and strength building of canines with muscle mass loss after prolonged immobilization after orthopedic surgery like TPLO for the repair of CCL rupture. The author reached out to the largest veterinary rehabilitation clinic in Sweden requesting them to provide any data on studies performed by them on the use of this tool. ReDog, Sweden was

generous enough to share the manuscript of a paper written by one of their fellows on the use of weighted leg cuffs in healthy dogs. The entire manuscript of this clinical study was translated from the original Swedish language into English and both versions are separately posted as pdf files and may be downloaded using the following URL links.

The following is a synopsis of the Swedish study, REDOG SWEDISH STUDY ON WEIGHTED LEG CUFFS:

Essentially the Swedish study examined the use of weighted leg cuffs in healthy dogs of several breeds, all one year age or older. 13 dogs of the following breeds were studied:

Dalmatian (1);

GSD (9);

GSD/Rottweiller mix (1);

Siberian Husky (1);

Alaskan Malamute (1)

All dogs were large breed dogs. The control dog was Dog #1 (Dalmatian) who wore leg cuffs without any weights, while the remaining 12 dogs were exercised

with weights of different amounts and durations. The youngest dog was one-year-old (Dalmatian) and the oldest dog was eight-years-old (GSD). The duration of the study was 30 days and measurements were taken on Day 1, Day 15 and Day 30 as follows:

- 1) The range of motion (flexion and extension) in the knee joint, the hip joint and the elbow joint checked with a goniometer.
- 2) Muscle mass was measured with an ordinary tape measure at:
 - a. Thigh muscle (Trochanter major/lateral patella)
 - b. Calf muscle (Distal crest tibia)
 - c. Upper leg muscle (Proximal armpit)
 - d. Lower leg muscle (Pisiform bone/dorsal olecranon)
- 3) A motion analysis was performed according to a fixed model on all dogs:
 - a. Standing
 - b. Sitting
 - c. Lying
 - d. From the front and rear (walking ordinarily and walking slowly)
 - e. From the side (walking ordinarily and walking slowly)

All 13 dogs were trained with a specific weight and for a specific time. A control dog (Dog 1) wore empty weight cuffs.

RESULTS

The dogs were be trained/loaded in a controlled manner by keeping the dog on a leash. The dogs were be warmed up for 10 minutes before the cuffs were applied. After the training, the dogs were cooled down for five minutes before stretching the forelegs and hind legs.

The exercise schedule was:

Week 1:

dog's weight 1x X kg = 1X grams in weight cuffs

Day 1: 5 minutes with weight cuffs, forelegs

Day 2: 5 minutes with weight cuffs, hind legs

Day 3:10 minutes with weight cuffs, forelegs

Day 4: 10 minutes with weight cuffs, hind legs

Day 5:15 minutes with weight cuffs, forelegs

SWEDISH STUDY CONCLUSIONS:

The Swedish study on weighted leg cuffs in healthy dogs showed a clear improvement in the movement pattern with increased range of motion and increased muscle mass in the dogs.

- The motion analysis showed the dogs to have developed a more deliberate lowering of their paws and have thus improved their movement pattern.
- 2) The dogs that were amblers have walked normally through the use of weight cuffs.
- The study also showed that the dogs that were uneven in musculature evened out their muscle mass.
- 4) There was no great difference in the amount of improvement between the various breeds in the study (all breeds improved uniformly)
- 5) The dogs that according to their owners were the least active, improved the most in range of motion and muscle mass. The dogs that were more active in winter improved in range of motion but less so in muscle mass.
- 6) Two dogs (Dogs 7 and 8) did not improved at all in muscle mass but did improve in range of motion. This may be because these dogs were trained the entire winter in (weight) pulling.
- 7) The control dog (Dog 1) that wore empty weight cuffs improved only in range of motion. This confirms the theory that if the goal is to build muscles in the dog, then the dog should be loaded with weights in the cuffs. If the goal is to improve the movement pattern, then using empty cuffs works.
- 8) The (training) setup with alternating the training with weight cuffs on front and hind legs (in order) to allow the muscles to recover between the training sessions, produced a very good result. Through the adaptation of the muscles to the training time and to the increased load, (as well as the rest time) the muscles developed in succession.

ADDITIONAL PUBLISHED MENTION OF WEIGHTED CUFFS:

Leg Weights and Resistance Bands:

The therapist can increase resistance to a particular limb or muscle group using a leg weight or elastic resistance band. Many leg weights designed for people do not fit properly. Human leg weights are often far too heavy, too large, and difficult to maintain in the desired position. Placement of the weight on the limb should also be considered. The stress on the limb is less when the weight is placed closer to the affected limb segment. A general rule of thumb is to use a weight that ranges between 1% and 3% of body weight, depending on limb strength and the stage of recovery. Leg weights are most effective in strengthening flexor muscles, which can be difficult to target with most active exercises." DATA REGARDING VEST:

Background:

Weighted vests have been marketed as a convenient exercise tool for all dogs regardless of breed or size or fitness level. These weighted vests have been promoted as an effective solution to canine obesity. Per manufacturers website, owners were not required to undergo any learning other than that they had to snap on these vests and go for a hike, which presented the advantage of easy conflict free acceptance of the tool by the owners. No user manual or exercise program is available for the use of the vests on the manufacturers website (as of April 1, 2020)

Based on social media posts by owners of weighted vests, these vests have been used for extended hikes spanning one or more hours over all forms of terrain in dogs of all age s ranging from skeletally immature dogs of 6 months age to senior dogs of 9 years age.

Veterinary Expert Opinion:

Veterinary experts board certified in veterinary rehab and/or veterinary orthopedics have however maintained that loading weighted vests onto the back of a canine is damaging for the following reasons:

- 1) Alteration of the load bearing characteristics of the canine spine.
- Alteration of and interference with the natural flex and extend of the canine spine that allows the transmission of the thrust

- forces generated by the rear limbs towards the forward propulsion
- 3) Increased impact stresses of the weights on the large joints of the shoulders, elbows, hips and knees of the dog....

EVIDENCE OF ALTERATION OF GAIT AND TRUNCAL MOVEMENT BY NON-WEIGHTED VESTS PAPER

PAPER 1: Dr.'s Timothy L. Foutz PhD & Steven C. Budsberg DVM, MS (School of Environmental, Civil, Agricultural and Mechanical Engineering, College of Engineering (Foutz), and the Department of Small Animal Medicine and Surgery, College of Veterinary Medicine (Budsberg), University of Georgia, Athens, GA 30602. Address correspondence to Dr. Budsberg: Budsberg@uga.edu)in a study titled "Impact of wearing a service vest on three-dimensional truncal motion in dogs" published a well-designed and executed study that addressed Item 1 & 2 of the 3 limitations that have been cited by Board Certified Rehab Vets and Veterinary Orthopedicians as negatives of the use of vests.

Essentially Foutz and Budsberg demonstrated significant alteration and restriction in gait, limb movement and truncal movement with either a service dog vest OR the military style tactical vest even when there were no additional weights added to these vests.

DATA REGARDING THE EFFECT OF HIGHER IMPACT LOADS ON CANINE LARGE BONE JOINTS: DAMAGING EFFECT OF EXCESS WEIGHT ON CANINE JOINTS PAPER 2:

<u>PAPER 2:</u> Several research studies have documented that excess weight in dogs due to obesity results in accelerated arthritis and degenerative damage to large joints of shoulder, elbows, hips and knees.... there are many studies in this area, but I will cite an authoritative review that establishes both the direct link between excess weight and arthritis but also how the reduction of excess weight results in improvement in arthritic symptoms even in established cases of

canine arthritis....

<u>PAPER 4:</u> OWNERS REGULARLY BELIEVE THEIR DOGS ARE NOT OVERWEIGHT EVEN WHEN SPECIFICALLY TOLD SO BY VETS:

<u>PAPER 5:</u> EXCESS NUTRITION RATHER THAN INSUFFICIENT EXERCISE IS THE DOMINANT CAUSE OF OBESITY AND OVERWEIGHT:

Proponents of canine weighted vests have claimed that the use of weighted vests is valuable in the fight against canine obesity by promoting exercise. However, examination of evidence shows that excess nutrition and quality of nutrition are the major drivers in canine obesity rather than primary lack of exercise. While veterinary experts agree that limited exercise does plays a role in both obesity and exercise, the evidence clearly points to the major contribution of nutrition as the driver for both obesity and arthritis and that it is not possible to effect elimination of obesity by exercise alone without addressing excess nutrition.

- Mean stride lengths for forelimbs and hind limbs at both velocities were shorter in obese than in lean dogs.
- 2) Obese dogs exerted greater peak vertical and horizontal ground reaction forces than did lean dogs.

The authors conclude that Greater ROM detected during the stance phase and greater ground reaction forces in the gait of obese dogs, compared with lean do gs, may cause greater compressive forces within joints and could influence the development of osteoarthritis. https://avmajournals.avma.org/doi/abs/10.2460/ajvr.74.5.757

The findings of PAPER 6 is significant when taken from another perspective. As already shown by Foutz & Budsford in Paper 1, non-weighted military style tactical and off the shelf service vests produce significant restrictions in limb and truncal movement and gait alterations. In Paper 6, Brady et al show that obesity itself produces shortening of the gait excursion. The data of Paper 1 and Paper 6 taken together suggests that putting a weighted vest on a non-obese canine may create the same conditions of limited gait excursion and higher peak vertical and horizontal ground reaction forces, and may cause greater compressive forces within joints..... in effect creating the same conditions that exist from a kinesiologic principle as obesity.

TOTAL WEIGHT LOADS USED IN WEIGHTED CUFFS AND WEIGHTED VESTS:

The Swedish study demonstrated favorable results at 1gram to 3 grams per kilogram of body weight per leg. This formula would mean that a 40-kilogram German Shepherd (88 lbs.) would be loaded with anywhere between 40 grams to 120 grams of weights in each leg cuff. This load translates into 0.1% to 0.3% of total body mass in each leg and a total combined 4-leg load of 0.4% to 1.2% of total body mass on the dog.

By contrast the manufacturer of weighted vests in the FAQ on their website reviewed on April 1, 2020 states that the vests are designed to add 7-10% of the total body mass onto the dog's spine and shoulders. This loading formula would mean that a 40-kilogram German Shepherd (88 lbs.) would carry a load of anywhere between 2.8 kilograms (6.16 lbs.) to 4 kilograms (8.8 lbs.) on their backs. The manufacturer also notes that some users have loaded the vests with weights up to 5 times the above loads (35-50% of total body mass) using BB shots instead of sand bags. A search of the manufacturer's website did not indicate whether any guidance was available regarding whether these loads were approved or not neither were we able to find any further guidance on any regimen or protocol of how these loads are to used or whether any activities are to be restricted. No manufacturer issued user manual could be found on the website.

A review of multiple documented posts of users of weighted vests in social media on a Facebook group devoted to users of the weighted vest was performed. The review revealed that multiple users were exercising their dogs while wearing loaded vests for durations of hikes spanning 1-2 hours over varied terrain as well as running and jumping over obstacles of varied heights (Social media accounts, pictures and videos). Pictures of dogs jumping and running wearing these vests are also prominently featured on the manufacturer's website.

All of this is not to state that weighted vests are absolutely damaging in all cases. Conversations with canine fitness experts indicate that there is a role for the carefully selected and carefully supervised use of weighted vests at much lower loads (not exceeding 2-3% of total body mass) in dogs that have already been trained to high levels of physical fitness, and even in those cases the use is highly restricted by top canine competitors to short periods(1-5 minutes) of tightly controlled activity. However, there is a huge difference in the loads of 0.1-0.3% of body mass per leg (0.4-1.2% total body mass) used in weighted leg cuffs for controlled leash walks of 10-15 minutes duration as reported in the Swedish study, compared to the loads of 7% to 50% total body mass reported by the users of weighted vests at uncontrolled pace of activity for extended durations of time. By all measures of data collection, it appears that the current use of weighted vest in the public is unrestricted, unselected, poorly supervised, and that actual use case scenarios

contravene established evidence showing the damaging effects of these kind of loads on the canine musculoskeletal architecture.

In conclusion, there is an abundance of evidence that though weighted vests may possibly beneficial in a very limited carefully selected population of very fit canines, the present manner by which weighted vests are being used runs counter to establish evidence for the safe performance of

canine resistance activity. By contract the available evidence for weighted cuffs demonstrate significant measurable gains in gait, movement and muscle mass with the use of fractional loads of only (0.4-1.2% total body mass) for controlled short durations of time (less than 15 minutes) at paces that are low impact and similarly controlled (leashed walks and controlled trots) without compromise of animal health or safety.

Anyone wishing to comment as to the character or qualifications of the new applicants may do so in writing to the Judges Committee Chairman, Nathaniel Roque. These written comments must be received no later than four weeks following the second publication of the new applicant's name.

The Apprentice Judges are those who have met all training requirements. Apprentice Judge Trainees are those who still have not met the training requirement of titling one dog through a SchH3, a second dog to a SchH1, as well as obtaining an FH on a dog trained by the candidate. The apprentice trainees are yet to fulfill all requirements of the program but are currently active in training a dog toward that goal. All of the requirements for the USCA Apprentice Judge Program can be obtained by contacting the USCA Director of Judges.
